



13. Audit :

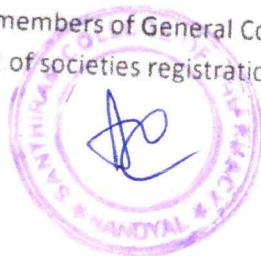
The accounts for the year commencing from April every year and place the audited accounts in the Annual General Body Meeting audited by the Chartered Accounts appointed by General Body.
