Whereas SANTHIRAM COLLEGE OF PHARMACY, Nandyal has agreed to educate their students on waste management and form Swachh WOW club in the college with the students to spread the message of source segregation to other students, and also agree to collect and handover the dry recyclable Paper.

1. NOW THIS MOU WITNESSETH AS UNDER:

This is an agreement for a synergic alliance between Santhiram College of pharmacy, Nandyal as Suraj Krishna Greeneries for the social cause of recycling of Dry waste paper and environment protection through recycling.


2. Time period: This MOU shall be for a period of 2 years from date of signing MoU.

Roles and responsibilities of Santhiram College of Pharmacy, Nandyal

- a. To ensure source segregation of dry and wet waste at college premises through its teaching staff, housekeeping staff and students.
- b. SANTHIRAM COLLEGE OF PHARMACY, Nandyal will give away any kind of paper waste, to Suraj Krishna Greeneries at price agreed mutually. Suraj Krishna will pay as rates mentioned below:
White paper & news paper: Rs 11/kg
Carton Boxes: Rs.2/Kg
- c. SANTHIRAM COLLEGE OF PHARMACY, Nandyal shall form **Swachh WOW club** in the college with student volunteers and adopt nearby Schools or Colonies to promote Source Segregation through student volunteers.
- d. SANTHIRAM COLLEGE OF PHARMACY, Nandyal shall motivate students to bring dry recyclable paper from their home and donate to WOW initiative.
- e. SANTHIRAM COLLEGE OF PHARMACY, Nandyal shall provide students for internship in WOW program.

3. Roles and responsibilities of Suraj Krishna Greeneries:

- a. ITC-WOW team will impart training to the students and housekeeping staff on source segregation and through them inculcate the habit of source segregation and through them inculcate the habit of source segregation among the other students.
- b. Suraj Krishna Greeneries will collect dry recyclable waste and old records from SANTHIRAM COLLEGE OF PHARMACY, Nandyal and bring to the hub for sorting and baling of the material collected and dispatch to recycling industries.
- c. Suraj Krishna Greeneries shall coordinate with ITC and undertake necessary measures for dispatch of the stored recyclables for recycling at its own cost.
- d. Suraj Krishna Greeneries will make payment to SANTHIRAM COLLEGE OF PHARMACY, Nandyal directly into their accounts for the dry recyclable paper waste collected against the accurate weight. The payment shall be made no later than 15 days from the date of payment request raised by the college. Franchisee on the request of Santhiram College of pharmacy, Nandyal may give new note books and stationary against the value of dry recyclable paper lifted.
