The University has constituted an Standing Committee for Affiliation to verify the reports which were submitted by the Fact Finding Committee for recommendations for granting Temporary affiliation for the academic year 2011-12. The Standing Committee for Affiliation of the University has verified the reports which were submitted by the Fact Finding Committee and made recommendations for granting Temporary Affiliation for the academic year 2011-12 vide (ref.6) read above.

The Standing Committee for Affiliation has identified the following deficiencies and recommended to rectify the same and submit a compliance report, before 25-11-2011.

- 1. Atleast two Governing Body meetings should be conducted in a year
- 2. Computer to student ratio should be maintained at 1:6. 30 more computers are to be procured
- 3. Atleast 50% of faculty appointments should be ratified by the University.
- 4. Laboratories for M.Pharm-Pharmaceutics should be established immediately
- 5. Faculty for M.Pharm-Pharmaceutics should be recruited immediately
